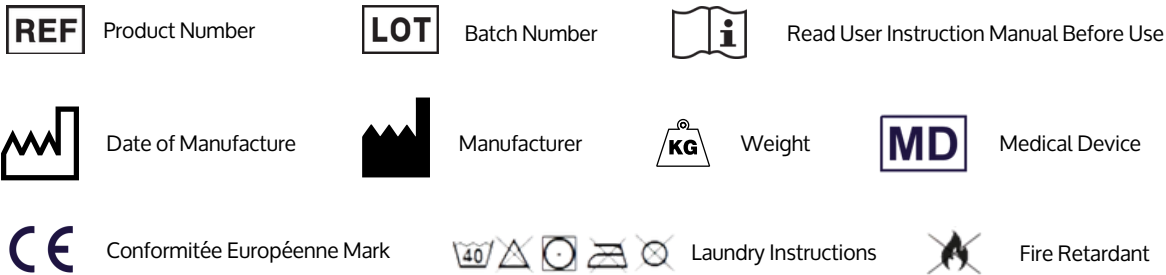

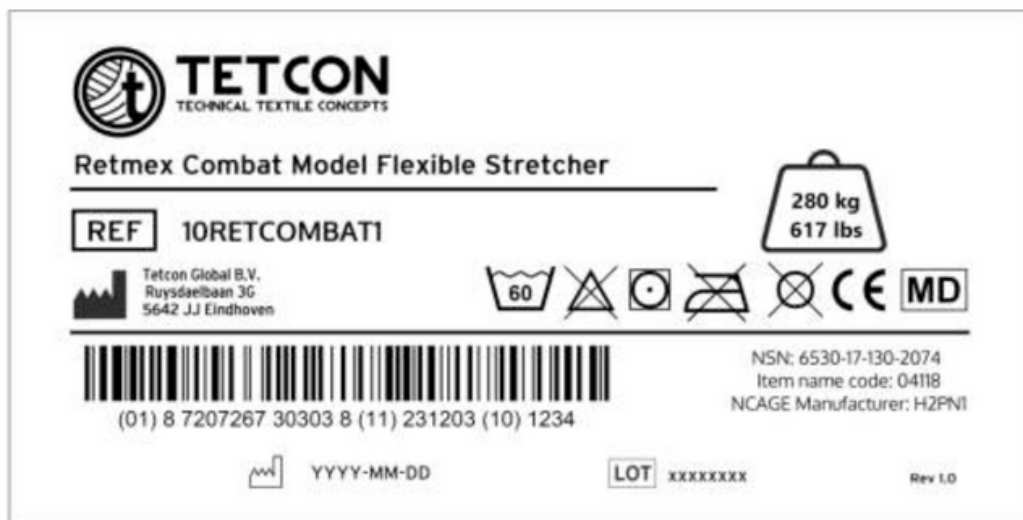

**Disinfection:**

After each use - clean the surfaces of the rescue sheet. The Rescue Sheet can be wiped off with a cleaning detergent (it is advisable to wear disposable gloves). After disinfection, ensure the product and its components are fully and completely dry before use.

**Cleaning in the washing machine:**

Whenever needed – you may also wash it in the machine at max. 60°Celsius. Do not bleach. Do not use washing powder with a fabric softener. Please only dry on a low temperature. Do not iron. Do not use high pressure water!

 **Replace the product if body fluids (e.g. blood stains) are still visible after disinfection or cleaning**

**Warranty:**

The Rescue Sheets have a 1-year warranty for material and manufacture faults, which is valid from the date of delivery.

# 6. Safety and Maintenance

## 6.1 Safety information



### WARNING

#### Retmex Rescue Sheet - Combat Model

This manual will help you to use the Retmex Rescue Sheet - Combat Model in a correct and safe way. Please refer to these instructions before using the product.

This Flexible Rescue Sheet is designed to provide a quick and easy way to extract wounded soldiers in the midst of combat. It is constructed from a lightweight, yet durable Cordura® material that can easily be carried and quickly deployed. The Retmex Combat Model is also known as a soft stretcher.

The Retmex – Combat Model is made with Cordura® fabric which is extremely durable and known for its military use. The sheet can be easily maneuvered, allowing you to also slide a victim along the ground if you are on your own and need to provide cover. This makes the Retmex one of a kind.

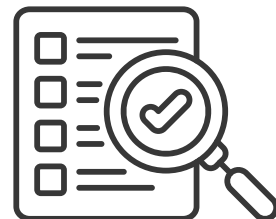
#### Safety information

- Always observe the instruction given in the instruction manual when using the Retmex.
- The Retmex is not intended for recreational use.
- Only use the Retmex in emergencies or during training.
- The use of alcohol and/or prescription and over-the-counter medicine may have a negative effect on the skill of the person operating the Retmex.

## 6.2 Maintenance Retmex

Maintaining and cleaning the Retmex Rescue Sheet is important to ensure efficient operation in the event of an extraction. It also ensures that your rescue sheet is up-to-date and properly maintained. Set up and follow a maintenance schedule. The schedule below represents minimum maintenance and you should modify your own program based on your needs.

As well as inspecting the Retmex after each use and before installing on bedframe, it must be inspected by a competent person. Records of inspecting can be recorded in the 'Inspection & Maintenance Manual' below.



Procedure	Frequency
Disinfection	After use or as needed.
Cleaning/washing	Cleaning and washing after each use. Also as needed.
Inspecting	Before installation and after each use.

## 6.3 Inspecting the Retmex

You should always inspect the Retmex before installation and after each use. This helps to ensure that it is in good condition and will not cause any problems during evacuation.

Check for signs of any damages that could weaken the Retmex such as broken crossboxes, broken stitching, holes, etc.

The inspecting record on the right you can use to check if the Retmex is still in good condition and can be used. It outlines all the components of the Retmex and provides information on checking the condition of each part. It shows where to look for possible problems, specific things to check, and general signs of wear and tear. By using this diagram, you can quickly and easily determine if the Retmex is still in good condition and if it can safely be used.



## 6.4 Inspecting Record - before using and after each use

- Are all components present? (Refer to page 6., Retmex Combat-Components)
- Are the clips of the restraint straps in tact? (Refer to page 6., Retmex Combat-Components)
- Is all webbing in good condition with no cuts or frayed edges?
- Is webbing stitching in good condition with no frayed or broken threads?
- Are any body fluids (e.g. blood stains) still visible after disinfection or cleaning?
- Is the fabric intact and not excessively worn?

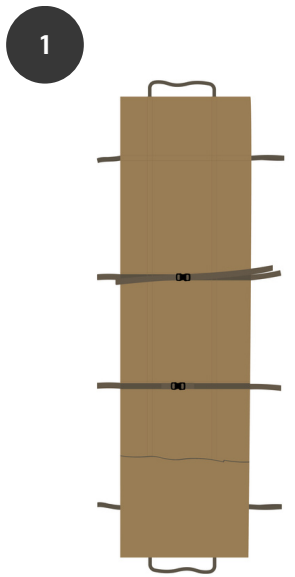
If inspection shows damage or excessive wear, remove the Retmex from service for further inspection or retirement.



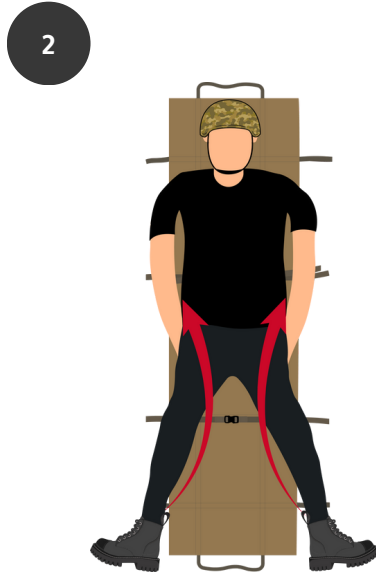
Do not attempt to repair or replace any materials or components.

# 7. Instructions for use

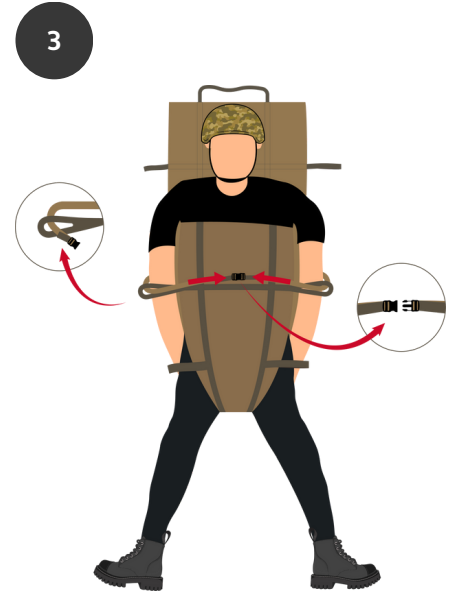
## 7.1 Instructions for dragging



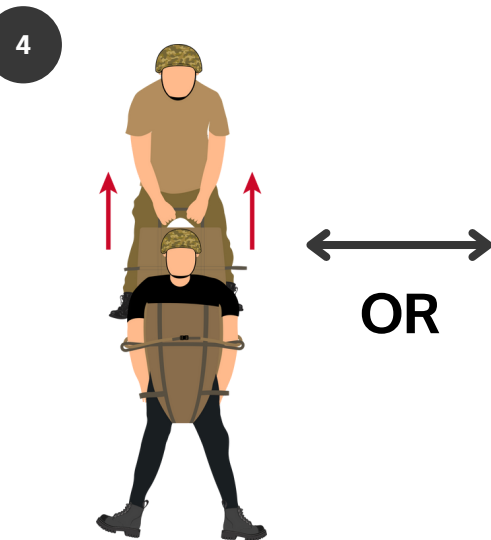
Open up the Retmex.



Pull the feet section between the patient's legs. Make sure that it sits like a 'diaper'.



To fixate the patient inside the Retmex, haul the fixation straps through the handles and close the fixation straps.



Now use the handle to drag the patient to safety.

If you operate the Retmex with two people, you can use the handles on the longitudinal sides for dragging.

### TIP

Make sure the arms are positioned underneath the fixation straps.



### WARNING

Friction due to dragging, sharp edges or protrusions may damage the Retmex and, therefore, reduce the effectiveness of the product.

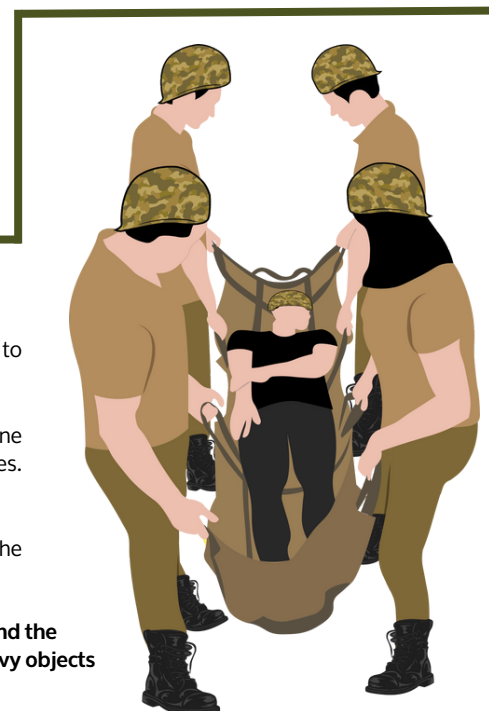
## 7.2 Instructions for lifting

- Position the patient in the centre of the Rescue Sheet. If necessary, you may use the logroll-technique to place the Rescue Sheet underneath the patient.
- When you operate the Rescue Sheet with two people, one person should stand at the feet end and one person should stand at the head end. Make sure to keep your back in a straight position to avoid injuries. Go through your knees before lifting.
- In an ideal situation, operate the Rescue Sheet with at least 3 or 4 users. Use the handles on the longitudinal sides of the Rescue Sheet to lift up the patient and transfer to a safe zone accordingly.



### WARNING

Be careful when lifting. Make sure you understand the correct manual handling techniques. Lifting heavy objects can result into serious injury.
